## **Kiama Tourism 2013/2014 Membership Terms and Conditions**

1. Kiama Tourism Membership program is on a financial year basis 01 July 2013 to 31 June 2014.
2. The level of membership selected should be dependent upon the level of services the organisation/operator wishes to receive (as per the membership prospectus inclusions).
3. Receipt of application does not guarantee acceptance of a membership with Kiama Tourism. Acceptance or otherwise of an Application for Membership will depend on the information supplied and relevant compliance with statutory requirements. Refused applications will have the full membership fee returned.
4. For Membership to be approved, payment in full must be accompanied by a signed MEMBERSHIP APPLICATION. Members who remain unpaid at 1 August 2013 will be marked as inactive on the Kiama Tourism website and brochures will be removed from the Visitors Centre and will remain as such until all fees are paid.
5. If Kiama Tourism does not receive a completed MEMBERSHIP APPLICATION the operator's details will be published as per the 12/13 Membership. Kiama Tourism will not take any responsibility for omissions or incorrect information or details if the correct information or details have not been supplied.
6. If a member of Kiama Tourism operates a business at a different physical location to the primary membership, the nominated second business (and any subsequent business) may be eligible for a discounted second or subsequent membership. NB: This does not refer to multiple functions at the one location – eg. Accommodation, conferencing, dining.
